The NEMRA Educational Scholarship Foundation: Information

The Program and Its Purpose

The National Electrical Manufacturers Representatives Association (NEMRA) has established the NEMRA Educational Scholarship Foundation to reward the academic excellence of sons and daughters of its members and their employees.

Administration of the Program

All phases of the scholarship competition, including selection of winners and determination of the amount of the scholarship awards, are managed by Career Opportunities Through Education (Coté), a nonprofit, scholarship service organization with extensive experience in management of scholarship programs.

Conditions of Eligibility

Applicants must:

1. Be children of members of NEMRA (and their employees) who are in good standing as of December 31, and
2. Attend or plan to attend (full-time) an accredited college, university, or vocational-technical school.

Preference will be given to applicants who demonstrate an interest, through club membership or a declared major, in business administration, marketing and sales, or electrical engineering-related fields.

The Application Procedure

Applicants must:

1. Be certain they meet the qualifications described in this brochure.
2. Fill out the attached application:
 - a. Complete and sign the application.
 - b. Detach the application from the brochure.
 - c. Secure a current and official transcript.
 - d. Secure a recommendation. This should come from an individual who can give an honest assessment of your academic and personal abilities, such as a teacher, pastor, college advisor, etc. (exclude friends and relatives).
 - e. Place your official transcript, completed application, and recommendation in a stamped #10 business size envelope (**two first-class stamps are required**).
 - f. Return all application materials postmarked no later than **January 21** to

The Selection Process

Coté has total responsibility for selecting the award winners on the basis of the student's academic record, participation in school and community activities, work experience, personal statement, and an applicant appraisal.

Coté receives the applications, makes the selection of award recipients, and determines the amount of the awards.

The Academic Awards

Three or more non-renewable awards are provided.

Recipients and prior year applicants are eligible to reapply in subsequent years.

All awards are made without regard to race, creed, color, sex, religion, or national origin.

Announcement and Distribution of Awards

All applicants will be notified regarding their recipient or non-recipient status on or about February 4.

The awards will be made by Coté on behalf of NEMRA. The award checks are payable jointly to the recipient and the school and may be used to pay for tuition, books, lab fees, or other related educational expenses. The award checks will be mailed directly to the recipient's home address in August.

The Responsibilities of the Student

Applicants to the NEMRA Educational Scholarship Foundation should remember that it is their responsibility to fulfill these requirements:

1. Gather and submit the information necessary for Coté to select the NEMRA Educational Scholarship Foundation recipients as described in this brochure.
2. Apply for admission to colleges, universities or other post-high school education programs.
3. Meet the entrance requirements of the institutions they have chosen.
4. Gain admission to the institution of their choice.

Obligation

No obligation of any kind will be imposed upon award winners by NEMRA. Further, NEMRA assumes no obligation in connection with the granting of the awards. However, NEMRA reserves the right to alter or discontinue the NEMRA Educational Scholarship Foundation at any time.

Notes

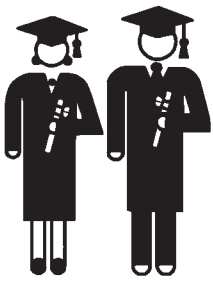
1. Award recipients will be asked to notify Coté of acceptance of the award by April 1.
2. The student is solely responsible for returning the completed application and a current and official transcript to Coté postmarked no later than **January 21**.
